- respect your wishes, if you tell us that you do not wish to have your personal information used or disclosed for a particular purpose, unless this is not legally or practically possible or conversely affects the purpose for which the information was submitted;
- 5. share information with several other Hire Companies, Mercantile Agents and Hire and Rental Industry as deemed necessary or reasonable for the purpose for which the information was submitted.
